ARTISAN VILLAGE CONTRACT TERMS AND REGULATIONS

- 1. WORK** All work shown **MUST** be the original creation of the exhibitor. Work made from kits or manufactured will not be allowed.
- 2. DISPLAY** Exhibitors must provide their own displays, booths, chairs and tables. Exhibitors should be prepared for sun, rain, and wind.
- 3. BOOTH** Space provided in the Artisan Village is approximately 10 feet (frontage) by 20 feet (deep). Buskers will sell their crafts as they walk around the Festival site. They will not be assigned a booth site. Buskers will be juried by the quality and originality of their work, as well as showmanship.
- 4. SELECTION** Exhibitors and Buskers for the Artisan Village are selected by a jury of the Summerfolk Artisan Village Committee from submissions on CD of 5 jpg photos per exhibitor.
- 5. FEE** Artisan booth - \$200.00. Fees for Artisan booths include weekend accreditation for two (value of \$160.00), a parking pass for one vehicle and food tickets redeemable at the food court. Up to two Artisans' children, 12 and under, are admitted free of charge if Summerfolk is notified in advance. Busker's fee of \$90 includes weekend accreditation for one and one parking pass. **Fees are non-refundable after June 14th.**
- 6. SETUP** Exhibitors shall set up from 10:00 a.m. to 4:30 p.m. on Friday, August 20th *but must be in the park no later than 3:00 p.m. for accreditation*. Booths must be set up by 4:30 p.m. Friday and must remain set up for the duration of the Festival. Booths may be dismantled after 9:00 p.m. on Sunday, August 22nd.
- 7. ELECTRICAL POWER** Each booth will have one outlet. Each exhibitor must supply his/her own lights and extension cords.
- 8. SITE ASSIGNMENT** Booth sites will be assigned by the Artisan's Committee at arrival time on Friday. Please keep in mind that this is an outdoor site and be prepared for uneven ground, slopes and occasional trees. Please indicate restrictions imposed by your booth design and we will attempt to accommodate your request.
- 9. PETS** Due to City regulations, NO PETS ARE ALLOWED on the Festival site.
- 10. CAMPING** Exhibitors may camp on their booth site if they use a small tent. There is space for trailers, large tents and campers at the Volunteer Camping area at the north end of the site (no electric or water hook-ups).
- 11. PARKING** Exhibitors receive one weekend parking pass for the South Lot (on site). Parking behind the booths is available at a limited number of sites, if the vehicle is an integral part of the booth display or is needed to protect vulnerable crafts in the event of severe weather.
To Qualify: i) the vehicle must look presentable and be necessary to Artisan's booth
 ii) the vehicle may not be moved from the site after 4:30 p.m. on Friday night and before 9:00 p.m. Sunday night

There will be no variation of these regulations and terms, unless confirmed in writing to you by May 15th, 2010.

If your application is accepted this form will become the contract for your participation at Summerfolk 2010. By signing this application you agree to the Artisan Village Contract Terms and Regulations. A copy will be returned with your acceptance letter.

I do not hold the Georgian Bay Folk Society, its officers or agents responsible for loss or damage of any kind. I have read and understand the rules and agree to observe them. I will exhibit only my original work.
