**SUMMERFOLK MUSIC AND CRAFTS FESTIVAL**  
**ARTISAN VILLAGE CONTRACT TERMS AND REGULATIONS**

1. **WORK** All work shown **MUST** be the original creation of the exhibitor. Work made from kits or manufactured will not be allowed.
2. **DISPLAY** Exhibitors must provide their own displays, booths, chairs and tables. Exhibitors should be prepared for sun, rain, and wind.
3. **BOOTH** Space provided in the Artisan Village is approximately 10 feet (frontage) by 20 feet (deep).
4. **SELECTION** Exhibitors for the Artisan Village are selected by a jury of the Summerfolk Artisan Village Committee from submissions of 5 jpg photos per exhibitor.
5. **FEE** Artisan booth - \$250.00. Fees for Artisan booths include weekend accreditation for two (value of \$280.00), and a parking pass for one vehicle. Up to two Artisans' children, 12 and under, are admitted free of charge, if Summerfolk is notified in advance. **Fees are non-refundable after June 2nd, 2017.**
6. **SETUP** Exhibitors shall set up from 10:00 a.m. to 4:30 p.m. on Friday, August 18th but must be in the park no later than 3:00 p.m. for accreditation. Booths must be set up by 4:30 p.m. Friday and must remain set up for the duration of the Festival. Booths may be dismantled after 9:00 p.m. on Sunday, August 20th .
7. **ELECTRICAL POWER** Each booth will have one outlet. Each exhibitor must supply his/her own CSA approved lights, extension cords, etc.
8. **SITE ASSIGNMENT** Booth sites will be assigned by the Artisan's Committee at arrival time on Friday. Please keep in mind that this is an outdoor site and be prepared for uneven ground, slopes and occasional trees. Please indicate restrictions imposed by your booth design and we will attempt to accommodate your request.
9. **PETS** Due to City regulations, NO PETS ARE ALLOWED on the Festival site.
10. **CAMPING** Exhibitors may camp on their booth site if they use a small tent. There is also space for campers at the Volunteer Camping area at the north end of the site (no electric or water hook-ups).
11. **PARKING** Exhibitors receive one weekend parking pass for the South Lot (on site). Parking behind the booths is available at a limited number of sites, if the vehicle is an integral part of the booth display or is needed to protect vulnerable crafts in the event of severe weather.  
To Qualify: i) the vehicle must look presentable and be necessary to Artisan's booth  
ii) the vehicle may not be moved from the site after 4:30 p.m. on Friday night and before 9:00 p.m. Sunday night
12. **INSURANCE** The Artisan Vendor shall, at their own expense, maintain public liability and property damage insurance (\$5,000,000) to protect the Georgian Bay Folk Society, the City of Owen Sound the Artisan Vendor against damage or loss of property from the operation of the festival Artisan Vendor Booth, as herein set out. (All must be named , with address, on the policy)

**There will be no variation of these regulations and terms, unless confirmed in writing to you by May 12<sup>th</sup>, 2017.**

If your application is accepted this form will become the contract for your participation at Summerfolk 2017. By signing this application you agree to the Artisan Village Contract Terms and Regulations. A copy will be returned with your acceptance letter.

I do not hold the Georgian Bay Folk Society, its officers or agents responsible for loss or damage of any kind. I have read and understand the rules and agree to observe them. I will exhibit only my original work.
